We present an overview of algorithms for large-scale optimization of partial differential equations (PDEs) with uncertain coefficients. Our algorithms minimize risk-based objective functions using sparse-grid discretizations. We consider both unconstrained and constrained formulations, applied to optimal design and inverse problems in acoustics.
